**AN ORDINANCE AMENDING TITLE XI, CHAPTER 111, SECTION 111.41 (A)
OF THE CODE OF ORDINANCES OF THE CITY OF GALENA, ILLINOIS**

WHEREAS, the Galena Code of Ordinances contains somewhat confusing language regarding the permission to provide entertainment on premises where alcoholic beverages are sold, and

WHEREAS, it is the desire of the City Council to clarify that requirement to assure all concerned are fully informed as to the permission to provide entertainment on such premises.

THEREFOR, BE IT ORDAINED by the City Council of the City of Galena, Jo Daviess County, Illinois, as follows:

SECTION I: Chapter 111, entitled "ALCOHOLIC BEVERAGES", of the Galena Code of Ordinances shall be amended at Section 111.41 thereof, entitled "ENTERTAINMENT", at subsection (A) thereof by deleting the language thereof and substituting therefore the following language:

- (A) Entertainment, limited to personal appearances of amateur or professional singing or theatrical performances, the use of musical instruments by amateur or professional entertainers, amateur or professional comedians or story tellers, the use of radios, electrical transcribing machines, phonographs, television or patron dancing or the showing of commercially produced motion pictures or videos shall be allowed on premises wherein alcoholic beverages are sold subject to all other provisions of this Title XI of this Code of Ordinances and, specifically, subject to Title XI, Chapter 117 of this Code of Ordinances

SECTION II: All other subsections of said Section 111.41 shall remain in full force and effect.

SECTION III: All ordinances or parts of ordinances conflicting with the provisions of this ordinance are hereby repealed.

SECTION IV: Passed on this 9th day of November, A.D., 2009, in open session.


