- Had some water under stage. Hole in tarp from a rock.

<u>Discussion</u>: A Memorandum of Understanding describing the relationship of the City of Galena, The Galena Foundation, and the Joe Miller Trust has been developed. Next step is for this Committee to recommend to City Council to approve the MOU.

Discussion: Further discussion on condition of building and short term projects.

- Lighting controls upgrade Lighting controls are failing again. Squirrel caused power surge that will require that lighting system be shipped to California for evaluation and reconstruction. More bad breakers as well. This will be done during time that building is unavailable. Money is in new budget to replace system. Team effort to get things fixed temporarily for Peace in Union. Galena Foundation will take proceeds of Hunter Fuerste Concert and apply it to the lighting controls upgrade. Training a group of people to operate light boards during events.
- Wi-Fi, HVAC and sprinkler system were also impacted by power surge. Possible insurance claim for all of the damage.
- LED Lights Testing several LED bulbs. Will complete after controls are upgraded.
- Having problems also with descending light fixtures which do not work properly.
 John Bookless will fix the descending light fixtures during building shutdown.
- Did some patching and painting to address moisture damage.

<u>Discussion:</u> Janelle Keeffer reported on ongoing marketing initiatives:

- Marketing budget is included in FY budget. Website and support materials will be developed in-house to reduce cost
- New rates are being positively received, including cost of setup and takedown for a four day rental. Janelle suggested a convenience fee that would allow a party using the hall to have access to the hall on Fridays after 4:30 p.m. if the hall is not rented that day. Same applies to Monday morning.

<u>Motion</u>: Albaugh moved, seconded by Fach that a \$200 convenience fee be established. <u>Discussion</u>: No additional discussion took place.

Smith will pursue the matter. Fach asked how the economic analysis is coming and indicated it is important to have it soon. Keeffer has done some research and will go to work on it shortly.
