**AN ORDINANCE AMENDING  
THE ZONING MAP OF THE CITY OF GALENA**

**BE IT ORDAINED** by the City Council of the City of Galena, Jo Daviess County, Illinois as follows:

**SECTION I:** The official Zoning Map of the City of Galena shall hereby be amended to change the zoning on approximately 3.5 acres, Parcel: 06-000-167-00, Part of Lot 1, Grant Hills Motel Place, S21, T28N, R1E of the Fourth Principle Meridian, Galena, Jo Daviess County, Illinois, from Limited Agricultural district to General Commercial district.

**SECTION II:** All other provisions of the Zoning Ordinance and the Zoning Map shall remain in full force and effect.

**SECTION III:** All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

**SECTION IV:** This ordinance shall be in full force and effect upon adoption.

**SECTION V:** Passed on this 24<sup>th</sup> day of August, A.D. 2020, in open Council.
