ORDINANCE NO. 0.18.07

ORDINANCE ANNEXING 20.84 ACRES OF TERRITORY IN RAWLINS TOWNSHIP

WHEREAS, a written Petition (marked as Exhibit A and made a part of this Ordinance), signed by Donald Wienen, the Owner of territory hereinafter described, was filed on February 16, 2018 with the City Clerk of the City of Galena, Jo Daviess County, Illinois, requesting that said territory be annexed to the City of Galena; and

WHEREAS, said territory, located in Rawlins Township, consists of two parcels (4.458 acres and 16.382 acres) totaling 20.84 acres, and is legally described in Exhibit B; and

WHEREAS, the are no (0) electors residing within the said territory; and

WHEREAS, the said territory is not within the corporate limits of any municipality, but is contiguous to the City of Galena; and

WHEREAS, in accordance with the <u>Illinois Compiled Statutes</u> (65 ILCS 5/7), legal notices regarding the intention of the City to annex said territory have been sent to all public bodies required to receive such notice; and

WHEREAS, copies of such notices required to be recorded, if any, have been placed as record in the office of the Recorder of Deeds of Jo Daviess County; and

WHEREAS, it is in the best interest of the City of Galena that said territory be annexed hereto.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Galena, Jo Daviess County, Illinois as follows:

SECTION I: That the territory described in Exhibit B is hereby annexed to the City of Galena, Jo Daviess County, Illinois, and that the boundary lines of Galena be and are

hereby enlarged and extended to include, within the corporate boundaries thereof, the territory above described and as shown in the Plat of Annexation, marked as Exhibit C and made a part of this Ordinance.

SECTION II: That the City Clerk is hereby directed to record with the Recorder and to file with the County Clerk, a certified copy of this Ordinance, together with an accurate map of the territory annexed.

SECTION III: That this Ordinance shall be in full force and effect after its passage, approval and publication as provided by law.
