

**AN ORDINANCE AMENDING CHAPTER 151, "HISTORIC PRESERVATION" OF THE CODE OF ORDINANCES OF THE CITY OF GALENA**

---

**WHEREAS**, Chapter 151 of the Galena Code of Ordinances regulates Historic Preservation; and

**WHEREAS**, Chapter 151.01 of the Galena Code of Ordinances designates the areas of the City of Galena having special historical, architectural, community or aesthetic interest and value as the Galena National Historic District; and

**WHEREAS**, Chapter 151.20 of the Galena Code of Ordinances describes the Galena National Historic District and its subdistrict boundaries; and

**WHEREAS**, The Mayor and City Council seek to align Chapter 151.01 and 151.02 with the previously adopted National Historic District Boundaries as depicted on the officially adopted Zoning Map of the City of Galena.

**NOW THEREFORE, BE IT ORDAINED** by the City Council of the City of Galena, Jo Daviess County, Illinois, as follows:

**SECTION I:** Chapter 151.01 (A), "Designated Area; Map", is hereby amended as follows:

- (A) All areas, places, buildings, structures, works of art and other objects individually and collectively, whether owner or controlled privately or by any public body located within the part of the city designated on the official City of Galena Zoning map labeled as "Historic District" are hereby designated as areas, places, buildings, structures, works of art or other objects having a special historical, architectural, community or aesthetic interest and value. This includes individually landmarked properties as outlined in Chapter 151.**

**SECTION II:** Chapter 151.20 (A), "Historic District and Subdistrict Boundaries", is hereby amended as follows:

- (A) The boundaries of the National Historic District (NHD) shall include the part of the city designated on the official City of Galena Zoning map labeled as "Historic District." This includes individually landmarked properties as outlined in Chapter 151.**
