# REQUEST FOR QUOTES FOR REPLACING STORM CULVERT MAY 2018

### INTRODUCTION AND GENERAL INFORMATION

The City of Galena is requesting quotes to replace a storm culvert on Monroe Street at 411 Park Avenue in the City of Galena.

#### SCOPE OF PROJECT

The City of Galena is requesting quotes to complete work detailed below. All work to be in accordance with latest versions of Standard General Conditions of the Construction Contract and City Specifications including Instructions to Bidders and General Requirements (copies available in City Hall).

- 1. Remove and dispose of 12 inch diameter 25 feet long CMP culvert, concrete headwall, surround material and trench backfill on Monroe Street at driveway to 411 Park Avenue.
- 2. New culvert to be 15 inch HDPE N-12 pipe 25 feet long with ¾ inch clean stone bedding and surround.
- 3. Upstream opening to culvert to be fitted with end section installed in accordance with manufacturers specification.
- 4. Downstream opening to culvert to have 8" thick concrete headwall of similar style and size to existing headwall.
- 5. Trench backfill and driveway to be compacted CA-10.
- 6. Place approximately 2 square yards of rip-rap material at downstream outfall.
- 7. Include for landscaping to restore any disturbed ground to original condition.
- 8. Work to be completed by Friday 29<sup>th</sup> June 2018.

## **CONDITIONS**

All work performed under this contract shall be subject to compliance with the Illinois Prevailing Wage Act, including latest revisions and the Illinois Preference Act. Contractors are required to submit certified copies of their payroll. Contractors must comply with the Drug Free Workplace Act (Source: P.A. 86-1459).

The City of Galena shall be exempt from any liability for costs incurred by unsuccessful bidders in preparation for this proposal.

The City of Galena will receive sealed quotes to complete the proposed work until: **10:00 AM Wednesday 23rd May 2018**.

The City of Galena will make payment within thirty (30) days after acceptance of the work. The City of Galena reserves the right to reject any or all quotes.
