

**REQUEST FOR QUOTES FOR PAINTING FIRE HYDRANTS
JUNE 2019**

INTRODUCTION AND GENERAL INFORMATION

The City of Galena is requesting quotes to repaint fire hydrants at various locations in the City of Galena.

SCOPE OF PROJECT

The City of Galena is requesting quotes to complete work detailed below. All work to be in accordance with latest versions of Standard General Conditions of the Construction Contract and City Specifications including Instructions to Bidders and General Requirements (copies available in City Hall).

Prepare hydrants for painting:

1. City will provide street map indicating locations of hydrants when contract is awarded.
2. Remove loose paint and corrosion using abrasive water blast and wire brushing.
3. Plywood screens to be used to protect nearby property from airborne materials.

Paint specification as follows:

1. A 'tent' will be assembled around each hydrant to protect adjacent buildings and property from paint overspray.
2. Apply high-solids PPG Amerlock 2/400 epoxy primer or equal applied at 2 to 3 mils. This will be sprayed on the surfaces to be painted in accordance with manufacturers specifications.
3. Apply high-solid PPG urethane PSX high gloss **SAFETY RED** or equal. This will be sprayed on the surfaces to be painted in accordance with manufacturers specifications.
4. A 'WET PAINT' sign to be placed at each painted hydrant and removed when paint has dried.
5. Contractor must provide details of primer and topcoat if above specified Amerlock paint products are not used.

CONDITIONS

All work performed under this contract shall be subject to compliance with the Illinois Prevailing Wage Act, including latest revisions and the Illinois Preference Act. Contractors are required to submit certified copies of their payroll. Contractors must comply with the Drug Free Workplace Act (Source: P.A. 86-1459).

The City of Galena shall be exempt from any liability for costs incurred by unsuccessful bidders in preparation for this proposal.

The City of Galena will receive sealed quotes to complete the proposed work until:

10:00 AM Wednesday 19th June 2019.

The City of Galena will make payment within thirty (30) days after acceptance of the work. The City of Galena reserves the right to reject any or all quotes.
