22C-0232 – CALL TO ORDER

Mayor Renner called the regular meeting to order at 6:30 p.m. in the Board Chambers at 101 Green Street on 27 June 2022.

22C-0237 - CITIZENS COMMENTS

Richard Pariser, 113 S. High Street – Pariser stated he thinks the cameras are a good idea. While active monitoring and intervening in real time would be great, he understands we cannot afford continuous monitoring. The system the city would be adopting is a passive recording system which takes picture. These pictures can provide leads to help solve crimes. Pariser stated he would like to see a report compiled after the first of the year which is data driven showing the efficacy of the project, the cost and a report on how well the system is working.

<u>David Sandlers, 1981 East Cross Road</u> - Sandlers advised his company, Arrow, Inc., is a local company who does IT and camera work. He advised he has been in discussions with the city about a camera system at the pool, Turner Hall and a unified camera system in the downtown as well. He listed several projects in the area completed by Arrow, Inc. Sandlers voiced concern with the city camera system not being put out for bid and questioned why. He felt the decision was made without relative information and it should be put out for bid.

<u>Jeff & Cynthia Bishop, 713 S. Bench Street</u> - The Bishops voiced concern with the additional traffic on Gear Street due to traffic being rerouted. Bishop advised he started installing a temporary fence along Gear Street. They currently have a chain link fence but would like to installer a denser material fence to help with noise from semis jake braking, diesel smell and dust. Bishop advised the fence would only be temporary while the work is being done and the traffic is rerouted. Bishop asked for the city's help to get a fence higher than four feet fast tracked in order to protect his property.

Kyle Vesperman, Vesperman Farms, 8149 Stage Road, Lancaster – Vesperman advised he recently applied for and received lunch stand permits for several Thursday Night Live events to operate his ice cream truck. After applying for and receiving the permits, he advised he received an email asking them not to come. Vesperman stated he does not understand why he is no longer able to come and questioned if he would get a refund of the permit fees paid.
