- The anchors that were in the old house, shaped as an 'S' will be incorporated in the stone.

- The service door will a fiberglass wood just like what is on his house at 316 Gear Street.

- They believe that the colors that were presented are not appropriate to Galena's Historic District.
- There is no purple color on any color charts old or new.

17HPC-108: 216 S. COMMERCE STREET.

Discussion and possible action on a request by XOCHI LLC, owner and applicants, to remodel the exterior of the existing structure located at 216 S. Commerce St. to reflect Spanish style architecture.

Damian Baumhover, IIW Architect explained:

- What the interior and the exterior of the building would look like.
- On the front, the owner is requesting a covered outdoor dining area, and a covered entrance.

- On the back addition, the owner is requesting to expand the kitchen, enclose a large freezer walk in, and have a dry storage area and have an office.
- The owner would like to expand on the look and feel of a Mexican look, with the Spanish tile, the arched windows, exposed vintage timber.
- The signage would be either down lite on the front, or lite from behind.

The HPC board stated:

- The building needs to look like it belongs here and this proposal does not meet the requirement.
- The lighting should be downcast with goose neck light over font.
- After much discussion, the HPC Board liked "Alternate A" the most.
- The building should have Galena cut limestone or brick.
