AN ORDINANCE AMENDING CHAPTER 111 "ALCOHOLIC BEVERAGES" OF THE CODE OF ORDINANCES OF THE CITY OF GALENA TO MODIFY THE CRAFT DISTILLER LICENSE

WHEREAS, the City of Galena is a municipal corporation operating under the laws of the State of Illinois; and

WHEREAS, Chapter 111 of the Galena Code of Ordinances regulates the sale and consumption of alcoholic beverages in the City of Galena, and

WHEREAS, Chapter 111.20 of the Galena Code of Ordinances establishes the classifications of liquor licenses and sets the fees for each classification of license; and

WHEREAS, Chapter 111.20 includes the Class "O" liquor license for craft distillery businesses; and

WHEREAS the City Council of the City of Galena seeks to create a supplemental license to the Class "O" liquor license for distillery pubs.

NOW THEREFORE BE IT ORDAINED by the City Council of the City of Galena, Jo Daviess County, Illinois, as follows:

SECTION I: Chapter 111.20 of the Code of Ordinances shall be amended by adding the following:

(P) Class "O-1" license shall be known as the distillery pub license. It shall authorize a craft distiller possessing a Class "O" craft distiller license to operate a distillery pub at a location in the city separate from the location of the craft distillery. The distillery pub is not required to distill at the distillery pub location. The distillery pub license shall allow the licensee to sell all alcoholic liquors, including beer, wine and spirts, including those spirits distilled at the location specified on the Class "O" license, at retail for consumption on the premises, or in packaged form for consumption off the premises. A pub distillery license shall permit the licensee to conduct tastings of spirits for which remuneration may or may not be received. A single tasting of distilled spirits shall not exceed one-fourth of one ounce. No more than three tastings of distilled spirits shall be provided to any person on any day. It shall be unlawful for such licensee to offer tastings or sell alcoholic liquor for consumption on or off the premises between the hours of 1:00 a.m. and 6:00 a.m., except New Year's Day, in which case such tastings and sales shall not be made between the hours of 2:00 a.m. and 6:00 a.m. The annual license fee shall be set by the City Council from time to time.

SECTION II: Chapter 111.22 shall be amended as follows:

There shall be no more than ten Class "A" licenses issued. There shall be no more than eight Class "B" licenses issued. There shall be no more than two Class "C" licenses issued. There shall be no more than four Class "F" licenses issued. There shall be no more than two Class "H" licenses issued. There shall be no more than two Class "I" licenses issued. There shall be no more than three Class "J" licenses issued. There shall be no more than two Class "O" and two Class "O-1" licenses issued. There shall be no more than two Class "P" licenses issued. There shall be no limitation on the number of Class "D," "E," "K," "L," "M" or "Q" licenses issued. There shall be no more than three Class "R" licenses issued.

SECTION III: In accordance with Chapter 111.20 (P), the fee for the Class "O" Distillery Pub license shall be \$1,125 annually.

SECTION IV: All subsequent paragraphs in Chapter 111.20 shall be renumbered accordingly.

SECTION V: All ordinances or parts of ordinances conflicting with the provisions of this ordinance are hereby repealed.

SECTION VI: Passed on this 10th day of May, 2021, in open Council.
