AN ORDINANCE AMENDING THE ZONING MAP OF THE CITY OF GALENA

BE IT ORDAINED by the City Council of the City of Galena, Jo Daviess County, Illinois as follows:

SECTION I: The official Zoning Map of the City of Galena shall hereby be amended to change the zoning on 3 parcels, approximately 2.92 acres, Parcels: Part of 13-000-075-00, S11 T28N R1W PT S ½ NE & PT N 1/2 SE, Common Address 11410 US Rte 20 W.; 13-000-078-33, S11 T28N R1W Galena Industrial Park PT Lot 6; 13-000-078-03, S11 T28N R1W Galena Industrial Park Pt Lot 1 and 50' x 100' of "A" Street; and 13-001-078-34, S11 T28N R1W Galena Industrial Park Lot 3 of Resub. of Lot 6, Galena, Jo Daviess County, Illinois from Limited Agriculture District to Heavy Industrial District on one parcel, and from Limited Agriculture District to Planned Commercial District on two parcels.

SECTION II: All other provisions of the Zoning Ordinance and the Zoning Map shall remain in full force and effect.

SECTION III: All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION IV: This ordinance shall be in full force and effect within ten (10) days of its passage and legal publication.
