**AN ORDINANCE AUTHORIZING THE SALE OF  
MUNICIPALLY OWNED PERSONAL PROPERTY**

**WHEREAS** in the opinion of the corporate authorities of the City of Galena, it is no longer necessary or useful to or for the best interest of the City of Galena to retain the items of personal property now owned by it and fully described as:

- 2 Multi-purpose Rope Rescue Devices
- 2 Rope Rescue Cams
- 1 Extra Large Carabiner
- 2 ISG Thermal Imaging Cameras

**BE IT ORDAINED** by the City Council of the City of Galena, Jo Daviess County, Illinois, as follows:

**SECTION I:** Pursuant to 65 ILCS 5/11-76-4, the corporate authorities find that the personal property described above, now owned by the City of Galena, is no longer useful and the best interest of the City of Galena will be served by its sale.

**SECTION II:** The City Administrator is hereby authorized to donated the rope rescue equipment to the Hills, Iowa Fire Department contingent on a waiver of liability being executed by the recipient department.

**SECTION III:** The City Administrator is hereby authorized to sell the thermal imaging cameras at fair market value to any interested first responder organization.

**SECTION IV:** This ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.

**SECTION V:** Passed on this 28<sup>th</sup> day of February, A.D., 2022, in open Council.
