**AN ORDINANCE AMENDING CHAPTER 151, "HISTORIC PRESERVATION" OF THE CODE  
OF ORDINANCES OF THE CITY OF GALENA**

**WHEREAS**, Chapter 151 of the Galena Code of Ordinances regulates Historic Preservation; and

**WHEREAS**, Chapter 151.24 of the Galena Code of Ordinances outlines the creation of the Galena Historic Preservation Commission; and

**WHEREAS**, Chapter 151.24 (D) of the Galena Code of Ordinances designates the meeting frequency of the Galena Historic Preservation Commission; and

**WHEREAS**, The Mayor and City Council seek to amend the frequency of meetings of the Galena Historic Preservation Commission.

**NOW THEREFORE, BE IT ORDAINED** by the City Council of the City of Galena, Jo Daviess County, Illinois, as follows:

**SECTION I:** Chapter 151.24 (D), "Meetings", is hereby amended as follows:

(A) Meetings. The GHPC shall meet once a month. Written notice must be given to all applicants with the notice to state time and place of the meeting in which their application


