**AN ORDINANCE AMENDING ARTICLE 0, SECTION §154.015 – DEFINITIONS OF THE
ZONING CODE OF ORDINANCES OF THE CITY OF GALENA**

BE IT ORDAINED by the City Council of the City of Galena, Jo Daviess County, Illinois as follows:

SECTION I: Section §154.015 – Definitions of the City of Galena Zoning Code, is hereby amended as follows

- *(Additions are shown as underlined)*

Section §154.015 - Definitions

Adult-Use Cannabis Business Establishment:

An adult-use cannabis cultivation center, craft grower, processing organization, infuser organization, dispensing organization or transporting organization. Except where co-location is allowed, all adult-use cannabis business establishments shall not be allowed within 1,500 feet of other adult-use or medical cannabis business establishments.

SECTION II: All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION III: This ordinance shall be in full force and effect within ten (10) days of its passage and legal publication in pamphlet form.

SECTION IX: Passed on the 24th day of February, A.D., 2020, in open Council.


