**AN ORDINANCE AMENDING  
THE ZONING MAP OF THE CITY OF GALENA**

**BE IT ORDAINED** by the City Council of the City of Galena, Jo Daviess County, Illinois as follows:

**SECTION I:** The official Zoning Map of the City of Galena shall hereby be amended to change the zoning on Parcel: 06-500-019-00, Wights Alteration of Pt Block 6, Block 6 Lots 9, 10, 11, & W 14' of Lot 8. Common Address, 101 Bouthillier St., Galena, IL 6103, from Low Density Residential to Neighborhood Commercial.

**SECTION II:** All other provisions of the Zoning Ordinance and the Zoning Map shall remain in full force and effect.

**SECTION III:** All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

**SECTION IV:** This ordinance shall be in full force and effect within ten (10) days of its passage and legal publication.

**SECTION V:** Passed on this 11<sup>th</sup> day of July, A.D. 2022, in open Council.


