AN ORDINANCE AMENDING CHAPTER 36.22: "VACATION LEAVE" OF THE CODE OF ORDINANCES OF THE CITY OF GALENA

BE IT ORDAINED by the City Council of the City of Galena, Jo Daviess County, Illinois, as follows:

SECTION I: Chapter 36.55 shall be amended to read as follows:

§ 36.22 VACATION LEAVE.

(A) Each full-time employee shall earn <u>five working days vacation after the</u> <u>completion of 90 days of service</u>, ten working days vacation per year after completion of one year of service; 15 working days vacation per year after completion of ten years of service; and 20 working days vacation per year after completion of 15 years of service; 21 working days of vacation per year after completion of 20 years of service; 22 working days of vacation per year after completion of 22 years of service; 23 working days of vacation after completion of 24 years of service; 24 working days of vacation per year after completion of 26 years of service; and 25 working days of vacation per year after completion of 28 years of service.

SECTION II: All ordinances or parts of ordinances conflicting with the provisions of this ordinance are hereby repealed.

SECTION III: This ordinance shall be in full force and effect immediately upon its passage and applicable to employees hired after December 1, 2021.
