

**AN ORDINANCE AMENDING CHAPTER 111 "ALCOHOLIC BEVERAGES" OF THE CODE OF ORDINANCES OF THE CITY OF GALENA TO INCREASE THE NUMBER OF AVAILABLE CLASS A LICENSES**

---

**WHEREAS**, the City of Galena is a municipal corporation operating under the laws of the State of Illinois; and

**WHEREAS**, Chapter 111 of the Galena Code of Ordinances regulates the sale and consumption of alcoholic beverages in the City of Galena; and

**WHEREAS**, Chapter 111.22 of the Galena Code of Ordinances sets forth the number of licenses available for each classification of liquor license; and

**WHEREAS**, the City Council seeks to expand the number of Class A licenses from 10 to 11; and

**WHEREAS**, the City Council of the City of Galena finds that to improve the economic prosperity of the community, it is the best interest of the City of Galena to amend the Alcoholic Beverages code to increase the number of Class A licenses.

**NOW THEREFORE BE IT ORDAINED** by the City Council of the City of Galena, Jo Daviess County, Illinois, as follows:

**SECTION I:** Chapter 111.22 of the Code of Ordinances shall be amended as follows:

There shall be no more than ~~ten~~ eleven Class "A" licenses issued. There shall be no more than eight Class "B" licenses issued. There shall be no more than two Class "C" licenses issued. There shall be no more than four Class "F" licenses issued. ~~There shall be no more than two Class "H"~~ licenses issued. There shall be no more than two Class "I" licenses issued. There shall be no more than three Class "J" licenses issued. There shall be no more than two Class "O" and two Class "O-1" licenses issued. There shall be no more than two Class "P" licenses issued. There shall be no limitation on the number of Class "D," "E," "K," "L," "M" or "Q" licenses issued. There shall be no more than three Class "R" licenses issued.

**SECTION II:** All ordinances or parts of ordinances conflicting with the provisions of this ordinance are hereby repealed.

**SECTION III:** Passed on this 13<sup>th</sup> day of November, 2023, in open Council.
