**AN ORDINANCE AMENDING CHAPTER 111 "ALCOHOLIC BEVERAGES" OF THE CODE OF ORDINANCES OF THE CITY OF GALENA TO ADD A "SERVICE, INSTRUCTION, OR EXHIBITION" LICENSE**

---

**WHEREAS**, the City of Galena is a municipal corporation operating under the laws of the State of Illinois; and

**WHEREAS**, Chapter 111 of the Galena Code of Ordinances regulates the sale and consumption of alcoholic beverages in the City of Galena, and

**WHEREAS**, Chapter 111.20 of the Galena Code of Ordinances establishes the classifications of liquor licenses and sets the fee for each classification of license; and

**WHEREAS** the City Council of the City of Galena seeks to create a new class of license for businesses that provide a service, instruction or exhibition.

**NOW THEREFORE BE IT ORDAINED** by the City Council of the City of Galena, Jo Daviess County, Illinois, as follows:

**SECTION I:** Chapter 111.20 of the Code of Ordinances shall be amended by adding the following:

(S) Class "S" license shall authorize the retail sale of wine, beer, or malted alcoholic beverages, for consumption on the specified premises, as a secondary and accessory use and in conjunction with a service, instruction or exhibition for which a fee is charged for such service, instruction or exhibition. Not more than one (1) alcoholic beverage may be served per hour to any attendee. In no event shall more than three (3) alcoholic beverages be served to any attendee.

**SECTION II:** Chapter 111.22 shall be amended as follows:

There shall be no more than ten Class "A" licenses issued. There shall be no more than eight Class "B" licenses issued. There shall be no more than two Class "C" licenses issued. There shall be no more than four Class "F" licenses issued. There shall be no more than two Class "H" licenses issued. There shall be no more than two Class "I" licenses issued. There shall be no more than three Class "J" licenses issued. There shall be no more than two Class "O" and two Class "O-1" licenses issued. There shall be no more than two Class "P" licenses

issued. There shall be no limitation on the number of Class "D," "E," "K," "L," "M" or "Q" licenses issued. There shall be no more than three Class "R" or Class "S" licenses issued.

**SECTION III:** In accordance with Chapter 111.20 (P), the fee for the Class "S" Service, Instruction or Exhibition license shall be \$500.00 annually.

**SECTION IV:** All ordinances or parts of ordinances conflicting with the provisions of this ordinance are hereby repealed.

**SECTION V:** Passed on this 26th day of June, 2023, in open Council.
