**AN ORDINANCE AMENDING
THE ZONING MAP OF THE CITY OF GALENA**

WHEREAS The owner and applicant submitted an application to rezone 3993 N. Council Hill Rd. , parcel 22-200-057-20, from Limited Agriculture to Low Density Residential.

WHEREAS, At the regular meeting of the ZBA on February 11, 2026, the ZBA voted to send a positive recommendation to the City Council to approve the application to rezone the subject parcel from Limited Agriculture to Low Density Residential.

WHEREAS The ZBA found that the request was in character with the surrounding districts and properties and recommended approval of the rezone 3993 N. Council Hill Rd., parcel 22-200-057-20 from Limited Agriculture to Low Density Residential.

BE IT ORDAINED by the City Council of the City of Galena, Jo Daviess County, Illinois as follows:

SECTION I: The official Zoning Map of the City of Galena shall hereby be amended to change the zoning on Parcel: 22-200-057-20. S17 T28 R1E Pt W1/2NE Corner, Galena, Jo Daviess County, IL 61036 from Limited Agriculture to Low Density Residential.

SECTION II: All provisions of the Zoning Ordinance and the Zoning Map shall remain in full force and effect.

SECTION III: All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.


SECTION IV: This ordinance shall be in full force and effect within ten (10) days of its passage and legal publication.

SECTION VI: Passed on this 23rd day of February, A.D. 2026, in open Council.
