**AN ORDINANCE APPROVING THE PURCHASE OF REAL ESTATE
AT 11420 DANDAR STREET, GALENA, ILLINOIS**

WHEREAS, the City of Galena, Illinois (hereinafter, "the City"), is a municipal corporation operating under the laws of the State of Illinois, in Jo Daviess County, Illinois; and

WHEREAS, the City, pursuant to Section 11-76.1-1 of the Illinois Municipal Code (65 ILCS 5/11-76.1-1), has the power to purchase real property for public purpose; and

WHEREAS, the City has determined that a 1.37-acre parcel ("the Property") owned by FMT Properties LLC should be acquired by the City for City purposes, including the Galena Police Department and other City Departments; and

WHEREAS, the City negotiated with FMT Properties LLC ("the Seller") to purchase the property under certain terms and conditions; and

WHEREAS, the City has agreed to purchase, and the Seller has agreed to sell the property described as "Part of the Southeast Quarter (SE ¼) of Section 11 in Township 28 North (T28N), Range 1 West (R1W) of the Fourth Principal Meridian (4th PM), Rawlins Township, Jo Daviess County, Illinois; property tax identification 13-001-078-52", commonly known as 11420 Dandar Street, Galena, IL 61036, for an amount of \$1,800,000 and other consideration, pursuant to a Real Estate Contract for Purchase (the "Contract") a copy of which is attached hereto and incorporated herein as Exhibit "A"; and

WHEREAS, the Galena City Council has determined that the purchase of the Property by the City and its use for City purposes, including the Galena Police Department and other City Departments, will provide benefit to the public in perpetuity.

THEREFORE, BE IT ORDAINED by the City Council of the City of Galena, Jo Daviess County, Illinois, as follows:

SECTION I: The recitals contained above in the preamble of this ordinance are hereby incorporated herein by reference, the same as if set forth in this section of this ordinance verbatim, as findings of the City Council of the City of Galena, Illinois.

SECTION II: The Contract for the purchase of the Property is hereby adopted.

SECTION III: The Mayor is hereby authorized and directed to sign the Contract on behalf of the City.

SECTION IV: This Ordinance shall take full force and effect upon adoption. YEAS: NAYS:
