

**REQUEST FOR QUOTES FOR REPLACING FIRE HYDRANTS
APRIL 2021**

INTRODUCTION AND GENERAL INFORMATION

The City of Galena is requesting quotes to replace fire hydrants at various locations in the City of Galena.

SCOPE OF PROJECT

The City of Galena is requesting quotes to complete work detailed below. All work to be in accordance with latest versions of Standard General Conditions of the Construction Contract and City Specifications including Instructions to Bidders and General Requirements (copies available in City Hall).

1. Hydrants for replacement to be decided by City staff and US Water.
2. Remove existing hydrants and replace with new hydrant with burial depth six feet. Hydrant and fittings to be supplied by city.
3. Provide and/or replace hydrant valve and hydrant lead as required by City. Valve and fittings to be supplied by city.
4. Trench backfill to hydrant and valves to be ¾" clean stone (CA-7) topped-off with material to match existing ground.
5. Reinststate ground around hydrant to match existing ground conditions with 4 inch topsoil, grass seed and straw mulch.
6. City will be responsible for obtaining water samples for bacteriological testing.

CONDITIONS

All work performed under this contract shall be subject to compliance with the Illinois Prevailing Wage Act, including latest revisions and the Illinois Preference Act. Contractors are required to submit certified copies of their payroll. Contractors must comply with the Drug Free Workplace Act (Source: P.A. 86-1459).

The City of Galena shall be exempt from any liability for costs incurred by unsuccessful bidders in preparation for this proposal.

The City of Galena will receive sealed quotes to complete the proposed work until:

10:00 AM Wednesday 12th May 2021.

The City of Galena will make payment within thirty (30) days after acceptance of the work. The City of Galena reserves the right to reject any or all quotes.
